Head to Toe Artistic Dance Company is a training ground for dancers ages 8-18. Our dancers study many styles of dance and perform throughout the year. Leadership and personal growth is developed, while our dancers take class, perform and have fun together.

Head to Toe Flight Co. is our company experience for dancers ages 5-7. These young dancers take classes in ballet, tap, jazz and acro, perform throughout the year and learn in a way that is developmentally appropriate for their ages.

Being a member of Head to Toe Dance Company is a rewarding, exciting and educational program for dancers. Our program will require an “above and beyond” commitment from each dancer and his or her family.

Our dancers learn so much more than dances and steps,
they develop **confidence** in themselves.

Dancers will be placed in their respective companies based on age and ability level.

Dancer Evaluations:

Evaluations are open to all dance students ages 5-19, whether or not they are currently on company or planning to audition for company. Company members (even those who are graduating) are required to attend.

Evaluation fee: \$30

Dress Code: black leotard and leggings and jazz shoes with their hair up. Dancers may wear ballet shoes if they do not own jazz shoes. Hair and makeup should be "performance ready".

10 AM: 9-12 Year Olds
11 AM: 13-18 Year Olds

Dress Code: black leotard and leggings and jazz shoes with their hair up. Dancers may wear ballet shoes if they do not own jazz shoes. Hair and makeup should be "performance ready".

ARTISTIC COMPANY TUITION AND REQUIRED CLASSES

Artistic Company Members are required to take classes year-round. Required classes are as follows: Ballet, Tap, Jazz, Contemporary, Acro, Hip Hop, and Company.

Summer Session is \$215 for unlimited monthly classes.

Fall Session is \$240 for required classes, additional \$20 for each additional class.
